This original 9Round is owned by founder Shannon Hudson. This is not the franchisor identified as 9Round Franchising, LLC. 9Round, LLC is not charged a royalty. A franchisee will pay \$300 a month or 5% of gross sales per month as royalty as more specifically defined in the franchise agreement.	
Through 2009 this gym was open Monday through Friday. It closed at 1:00 PM on Saturday and was closed Sunday. This is a personal decision by Shannon Hudson. Starting in February of 2010, the gym will be open Sunday afternoons. There are no restrictions on a franchisee keeping hours as they determine appropriate in their market.	
This original gym has been in operation since March 5, 2007 however it relocated to the present location in July 15, 2008 upon the departure of a partner. Shannon Hudson of 9Round Franchising, LLC does not believe that 9Round, LLC financial statements prior to January, 2009 accurately represents the business models capability of performing as indicated in this Item 19 financial performance representation.	
It should be noted that revenues trended upward throughout 2009. For the 1st quarter 2009 averaged \$7,993 per month; revenues averaged \$10,423 per month in the 2nd quarter of 2009; revenues in the 3rd quarter of 2009 averaged \$11,409 per month; the 4th quarter monthly average was \$12,430 per month.	
Expenses do not include an owners management expense. The franchisee may choose to take salary or distributions or choose other means to meet financial compensation goals. Shannon Hudson works part-time at 9Round, LLC.	
All Other Expense includes expenses pertaining to equipment maintenance, general office, communications, credit card fees, insurance, facility maintenance, legal and accounting, utilities and other miscellaneous yet minor business expenses.
